WORKSHOP - UPDATE OF WIRELESS FACILITIES CODE

Meridee Pabst, Wireless Policy Group, was present to continue discussing the draft wireless facilities code update. Staff incorporated changes discussed at the last workshop and handed out an updated draft wireless code.

Further changes were discussed including:

- * Allowing ability for staff to use third party review for other elements, not just RF engineering.*
- * 35' above maximum building height in commercial zones*
- * No Type 3 towers in the Regional Commercial zone*
- * No towers in the Downtown Commercial district*

The Planning Commission requested visual aids at the next workshop.
