- Mowing routes have been reduced to as needed
- Softball field preparation continues for fall leagues until September 27th
- Color baskets have been removed
- Park use continues at a very high level and has increased weekend rest room and trash hours
- Security company continues to inspect and lock all rest rooms and Asian island
- Majority of Parks have been weed whipped and edged
- Watered Tennant Way planters with water truck 2 times weekly
- Large area weed control continues at Lake, medians and ROW's
- 17 sharps collected from Park areas this period
- Leaf mulching has started via large area mowers
- Have majority of the City edged for the fall
- 22 Vandalism work orders with costs of \$3783 this period
- Have started fall weed control
- Playgrounds have been top dressed with chips for the winter
- Mulching of tree wells and beds complete
- Fall aeration has started
- All irrigation has been stopped for the season
- Summer staff has returned to college and looking for replacements
- New playground installed at Kellogg Park
