RECOMMENDATIONS REGARDING CONDITION OF PLAZA AT R.A.
LONG PARK****RECOMMENDED ACTION:**

Acknowledge historic preservation commission recommendations and provide direction to staff about proceeding with demolition.

Council discussed the plaza demolition and the consensus was to move forward with the motion recommended by the Historic Preservation Commission as submitted to the council by the HPC's staff representative, Planner Adam Trimble. Cam Hanna, Chairman of the Historic Preservation Commission (HPC), was in attendance and participated in the discussion as well.

A motion was made by Council Member Mary Jane Melink, seconded by Council Member Chet Makinster, to carry over previously approved and unspent City funds, including \$300,000 from the Kuntz Family Trust, for Phase 1 renovation of R.A. Long Park, including the reconstruction of the central plaza, in a historically appropriate manner, and provide for modern accessibility, and direct staff to proceed with the re-design process with a goal of completing the project by the end of 2018, with prior approval of the new design by the Historic Preservation Commission, the Parks and Recreation Board, Project Longview, and the City Council, and to consider and seek additional funding including grants, donations for enhancements, and other City resources as necessary and available for the project budget. The motion passed unanimously.
