**COWLITZ-WAHKIAKUM COUNCIL OF GOVERNMENTS (CWCOG)**

**SERVICES****CITY ATTORNEY REVIEW: N/A****SUMMARY STATEMENT:**

During the process of amending the 2015-2016 biennial budget last December, the City Council voted to authorize payment of the first half of the City's 2016 annual dues to the Cowlitz-Wahkiakum Council of Governments, but not to make the second six months' payment until conducting a review of the organization's services to the City. CWCOG staff will make a presentation during the Council's April 21 Workshop outlining the services they provide for the association of general and special purpose member governments and agencies in the Lower Columbia region. The primary focus will be on the direct and indirect benefits to the City of Longview as a general member participant.

**RECOMMENDED ACTION:**

No action is required during the workshop, but staff will need Council direction within the next month whether or not to make dues payments to the CWCOG for the second half of 2016.

*Cowlitz-Wahkiakum Council of Governments (CWCOG) Executive Director Bill Fashing presented a slideshow of the current services provided by CWCOG. After discussion, the council directed staff to bring a proposed budget amendment forward for a decision at a regular council meeting in June; at that time, the council will decide whether or not to pay the second half 2016 membership dues to CWCOG. City Manager Campbell emphasized to council that historically, Longview has received much more in value in various different types of grant and other funding than our basic dues have represented. Additionally, the City would not be eligible for many types of grants if it were not a member of CWCOG.*

*Mayor Jensen invited constituents to speak on the topic of Longview's relationship with the CWCOG.*

*Michael Greene, Superintendent of the Woodland School District, spoke in favor of Longview's continued membership with CWCOG. Mr. Green explained that many of the schools maintain a membership with CWCOG because the districts recognize that economic development of the region and transportation infrastructure benefit families and promote working wages that benefit kids in the school district.*

*Jeff Wilson of Longview addressed COG Director Fashing regarding the COG's auditing agency and employees.*
