

*Currently, data centers are not addressed in the City's zoning code. Since data centers are typically found in urban area, it is appropriate for the City to determine the appropriate zoning districts for that land use. Allowing data centers in the industrial districts should not significantly increase discharges and emissions greater than other industrial uses already allowed in the industrial districts.*

Proposed measures to avoid or reduce such increases are: *None*

2. How would the proposal be likely to affect plants, animals, fish, or marine life? *The proposal is not likely to affect the above. See answer to question one.*

Proposed measures to protect or conserve plants, animals, fish, or marine life are: *None*

3. How would the proposal be likely to deplete energy or natural resources? *The proposal to allow data centers in the industrial districts is not likely to deplete energy or natural resources. However, data centers can have high energy (electrical) demand. This potential high energy demand can be addressed at project development.*

Proposed measures to protect or conserve energy and natural resources are: *Methods to conserve energy will need to be addressed on a project to project basis.*

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands? *The zoning districts already allow for a wide range of industrial and commercial land uses. Adding data centers to list of allowed uses should not significantly impact the above*

Proposed measures to protect such resources or to avoid or reduce impacts are: *Any data centers constructed as a result of the code amendment would need to undergo environmental permitting if required.*

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

Proposed measures to avoid or reduce shoreline and land use impacts are: *Any buildings constructed as a result of the code amendment would need to comply with zoning and building standards and undergo environmental permitting if required.*

Proposed measures to reduce or respond to such demand(s) are: *Cowlitz County Public Utility District provides electrical service in the City of Longview. The PUD will need to evaluate each data center project on a case by case basis to ensure that the project will not have an undesirable impact on the power system.*
