The homeowners asked the board to consider removal of these trees as this species are already showing concrete damage to recently repaired sidewalks. Curt Nedved shared the process for deciding which trees were removed during that project, and indicated that the trees were deemed healthy and not chosen for removal. Curt reported the trees had been inspected within the last year. Per board policy, problematic species is not listed as one of the five criteria for tree removal.
