A diverse group of local volunteers will be uniting to hold a Clean-Up and Renewal Project at the Cloney Skateboard Park on Washington Way, located near Lake Sacajewea as a Community Service Project. Our team of volunteers is formed of local Longview citizens from all corners of our community. Our goal is to completely wash, clean, maintain, and restore various aspects of the facility. Along with landscaping, raking, sweeping, and pressure washing, we will be prepping, taping, and priming each of the skate park obstacles throughout the entire park to apply colorful murals of geometric designs. Need:

For many years our local skate park has suffered from graffiti, vandalism, malicious mischief, underage tobacco use, illegal drugs, and alcohol abuse as a of the declining sense of Home-town Pride and an increasing lack of respect for society. This leaves our local students and children vulnerable to many degrees of illegal activity. The local Cloney Skate Park facility is currently in, and has been in, the utmost dire need of serious attention from our community members and local authority figures. Skateboarding provides physical activity and a positive outlet for people of all ages. Revitalizing this area with not only benefit the skateboarding community, but artist value to the community as a whole. This specific area Longview is desperate need of genuine and intelligent efforts to restore the nature of its struggling society.

Community Impact:

The local citizens of this low-income neighborhood will be significantly affected by this cosmetic beautification process that will dramatically change the visual and psychological perception of this struggling division of Longview. Other individuals who will directly benefit from this project are the high-school students who will receive "community service hours" that are a requirement for graduation, along with the team-work/problem solving skills that will provide a true hands on experience in a real world scenario. The geometric theme that will be incorporated into the project will also be beneficial to the students in the sense that it is educational and be related back to the classroom. The city benefits because this project was designed to combat vandalism, crime, boost economy, and also maintain the upkeep of our community facilities. Our goal is to generate town pride and to uplift our society and make it a better place to live.

Access:

The park has free daily access to the public.

Financial Responsibility:

This project will produce an increase in student learning because of the incorporated mathematics within the project. Additionally, the city will receive a newly revitalized park which will provide an increase amount of community pride. Project designed to be annual through the non-profit with the help of the school district and volunteers. Maintenance requirements will be ongoing provided by the non-profit.

Cost Benefit:

The local businesses who have contributed to the project will receive free promotional advertisement to encourage the stimulation and growth of the local economy/commerce. This program also has the potential to branch out to painting more murals within the community to bring about a wave of positive culture. This project provides significant and long lasting effects, impacting multiple aspects of our society, from psychological to physical, and even economically.
