When Amos Peters built the Nutty Narrows Bridge, in 1963, he never dreamed of the world wide attention it would receive (and continues to receive), the recognition it keeps bringing to the City of Longview, a squirrel statue, a Squirrel Fest, and the second generation of squirrel bridges! We have a plan to enhance the sculpture area with an informational panel, a sidewalk, a park bench, lighting, and a refurbished base. We consider the sidewalk to be indispensable; therefore we are applying for assistance to help us pay for this critical centerpiece of the plan.

The project is planned to be compatible with construction of the Shay Pavilion, but, FINANCIALLY, they are two separate projects with separate funding.

In 1985, a ten-foot wood squirrel sculpture was placed by the Longview Sandbaggers in memory of their member, Amos J. Peters, the designer and builder of the Nutty Narrows Bridge. Through its fifty-plus years, it has been said, the Nutty Narrows has brought more attention to the City of Longview, than any other single feature. From the 1963 evening when the concept of a squirrel bridge was approved by the City Council, the little bridge has been featured in media around the world. Today a Google search identified 2,430 web sites related to the bridge and/or the sculpture. Travel sites list them as "must sees". In 2013, the web site for "Roadside America" listed the bridge as "worth a detour"; now, in 2015, it has expanded to include a photo and history of the sculpture. Wikipedia presents the history of both. In 2014, the Nutty Narrows Bridge was added to the National Register of Historic Places, giving prestige to both attractions.

The sculpture was the brain-child of the Sandbaggers, a raucus group of fun-loving men, who, for nearly fifty years, have promoted Longview through creative pranks. They replaced the worn and rotted first sculpture after giving fifteen years of community pleasure. This creative group has repaired and repainted the sculpture on a regular basis, while the Parks Dept. has carefully maintained the surrounding area and the Nutty Narrows Bridge. The Sandbaggers support the sidewalk addition (Attachment 1).

Since its first installation, the squirrel sculpture has stood in Library Park surrounded by grass. People got their shoes wet and wore paths in the grass to reach it. Through the years many folks using walkers or wheelchairs, or pushing strollers, either struggled to maneuver over the grass, or peered at the sculpture from a distance.

When site-plans for the Shay Pavilion were to be revised, some community residents requested the addition of a sidewalk to the squirred sculpture. This revised plan (Attachment 2) includes sidewalks up to and around the squirrel. The maximum cost estimated for the squirrel sidewalk is \$5,950 (Attachment 3). These funds are SEPARATE from the funds being raised for the Shay Pavilion. In order to assure uniformity, and reduce costs this project is being coordinated with the City of Longview, the Shay planning committee and the Friends of Longview.

<u>Project Relationship to Grant Rating and Instruction Criteria</u>. (Explain how this project responds to the eight rating criteria listed in the application process. NEED: A sidewalk integrates the sculpture into the park experience instead of it being set off by itself. Not only is there no similar facility in this community and state, there is no similar facility in the world! Both the sculpture and the locomotive are part of the unique history of Longview. It will be much easier and safer for all to get to view the squirrel up close, and to read the memorial plaque and the proposed informational panel.

COMMUNITY IMPACT: The attraction demonstrates the creativity of local people and brings joy with its whimsey. It has already demonstrated community impact with all of the media attention and resulting interest of tourists. Because there is no charge, low-income folks are given a delightful place for an outing, to share a picnic, take photos, and to watch for squirrels in and around the adjacent trees.

ACCESS: Library Park is open to the public at all times. By providing a sidewalk, made to ADA standards, people of all ages, and all ambulatory abilities will be able to reach the sculpture, read the memorial plaque and proposed informational panel. They will be able to appreciate the creativity and workmanship of both the sculpture and the Nutty Narrows Bridge.

FINANCIAL RESPONSIBILITY: The anticipated life span of concrete sidewalks is fifty years with minimal maintenance. However, breakage can occur if trucks are driven over it. There are no trees close to this sidewalk so damage from root heaving is unlikely to occur. Tangible returns occur when, as part of their trip to see the sculpture and bridge, tourists eat meals, and make purchases from local businesses. Intangible returns are the warm feelings and delight that arise within people from being in a city that embraces its arts and history.

COST BENEFIT: Tourists are known to have eaten meals and visited Longview businesses after visiting the sculpture and bridge. Residents and tourists, alike, will benefit from safer, easier walking up to the sculpture. The likelihood of trips and falls, from uneven and wet grass, will be reduced. People using mobility assistance (canes, walkers, wheelchairs) will have a comfortable means to reach the sculpture. Children will develop pride in their community when they are exposed to the sculpture, the locomotive, the squirrel bridge and the Monticello Convention display, through library and school services, and community events such as Squirrel Fest.

Costs will be reduced by coordinaing construction of this sidewalk with those being constructed for the Shay Pavilion. The concete work is anticipated to be comleted in April, weather permitting.

COMPLIANCE: The Historic Preservation Commission has approved the sidewalk plans. This project also supports the 2012 Initiative of Preserving and Enhancing Neighborhoods and Quality of Place Issues.

READINESS TO PROCEED: Contributions from the community currently are being received for the match. A pledge has been received to complete the match, if needed (Attachment 4). Construction of this sidewalk is being coordinated with that for the Shay Pavilion; therefore, no separate permits or labor will be needed.

FUNDING: Community donations, specifically for the sculpture sidewalk, are being received. A pledge has been made to cover any deficit of the match. Coordination is with Brian Magnuson, general contractor for the Pavilion and Friends of Longview, the group designated by the City to raise and expend money for the Pavilion. This project will benefit from any reduced costs and volunteer labor negotiated for the Shay Pavilion

We are pleased with the enjoyment people have receive from this sculpture through the years.


We believe a sidewalk will enhance accessibility to the sculpture and will add to the overall appearance and functionality of the park.
