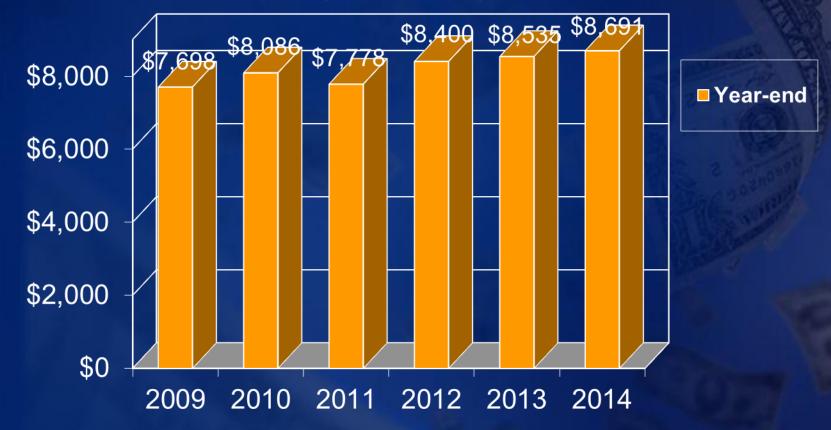

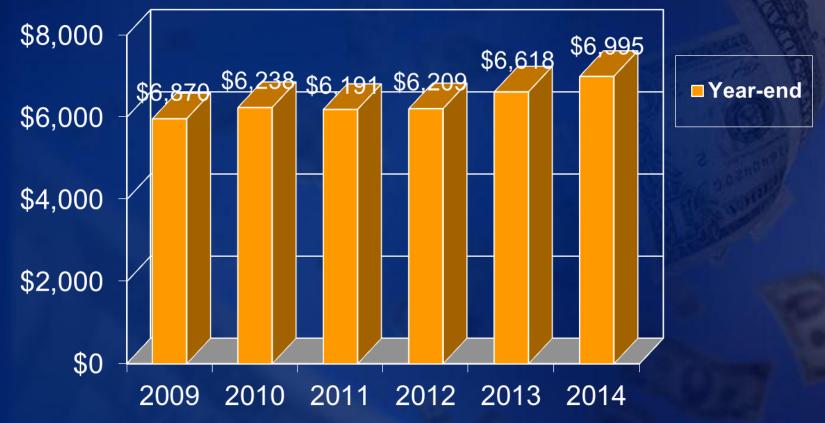
History of Property Taxes (in 000's)



2014 Budgeted Property Tax = \$8,621,380

Comment: "2014 property taxes in the amount of \$8.69 million are up 1.8% over 2013." Property taxes in the amount of \$455,000 were allocated to the Economic Development Fund for debt service on the Mint Farm Industrial Park.

History of Sales Taxes (in 000's)



2014 Budgeted Sales Tax (Amended) = \$6,987,240

Comment: "Year-end 2014 sales tax revenues in the amount of \$7.0 million is up \$377k more than 2013 actual sales tax collections of \$6.6m and represents a 5.7% increase."

Auto +7.6%

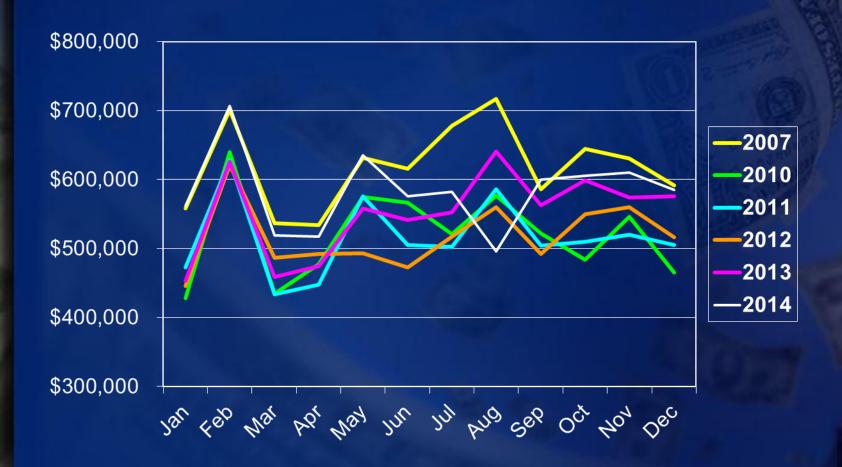


Home Improvement +1.4%

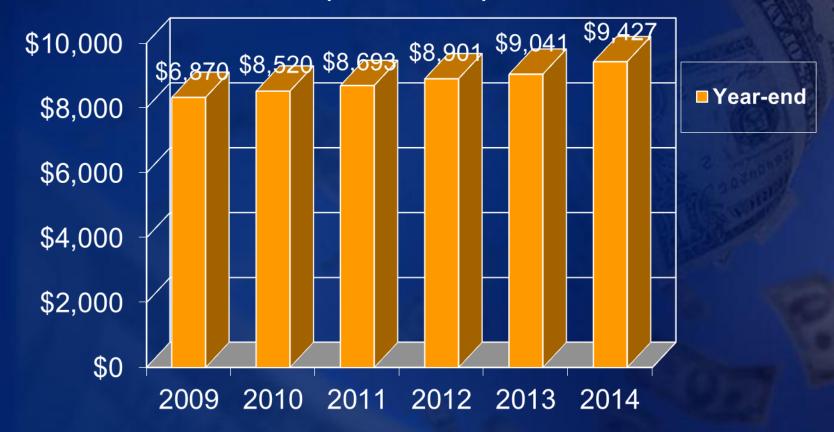

Comment: "2014 sales tax revenue is at its highest level since 2007."

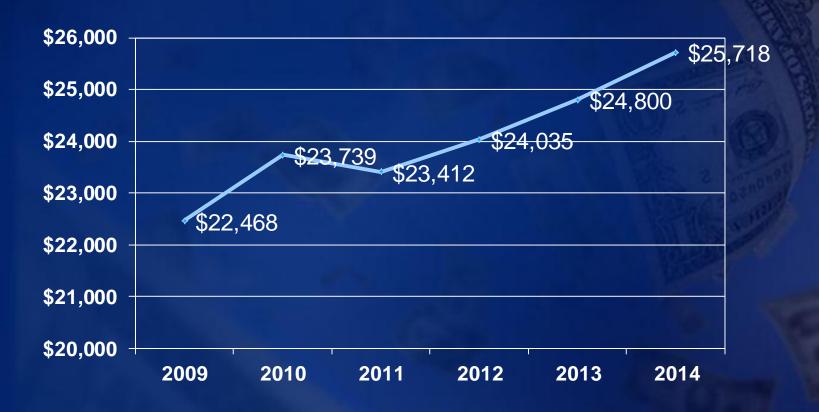
History of B&O Taxes (in 000's)



2014 Budgeted B&O Tax (Amended) = \$9,316,940

Comment: "Year-end 2014 B&O tax revenues in the amount of \$9.4 million are \$386k more than 2013 B&O tax collections of \$9.0m and represents a 4.3% increase."

Comment: "2014 total taxes in the amount of \$25.7 million are up 3.7% over 2013 taxes."

General Fund Revenue (in 000's)



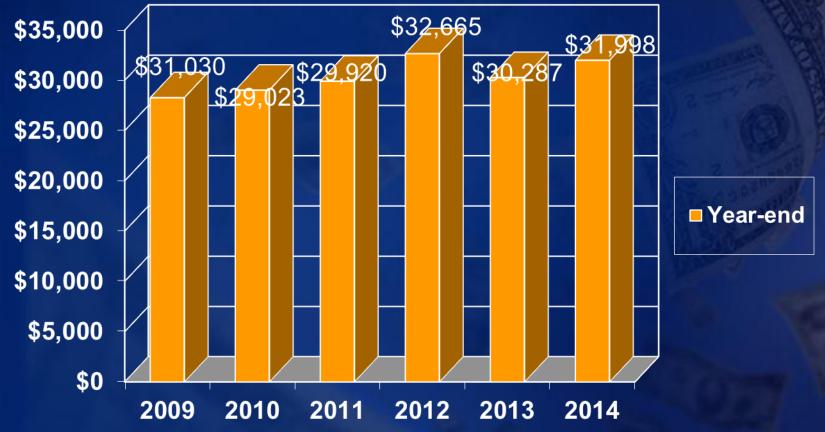
2014 Budgeted Revenue (Amended) = \$32,160,540 Comment: "2014 General Fund revenue in the amount of \$33.0m represents a \$1.3m increase from 2013 revenue of \$31.7m. 2014 General Fundo revenues reflect a 4.2% increase."

Comment: "2014 revenues are \$850k more than budgeted. Actual revenue exceeded budgeted revenue by 2.6%. Intergovernmental revenues accounted for a major share of this increase and are \$426k greater than budget. Taxes realized came in \$205k ahead of budget."

General Fund Expenditures (in 000's)



2014 Budgeted Expenditures = \$33,605,660

Comment: "2014 General Fund expenditures of \$32.0 m are \$1.6 m less than budget and represent 95.2% of total appropriations."

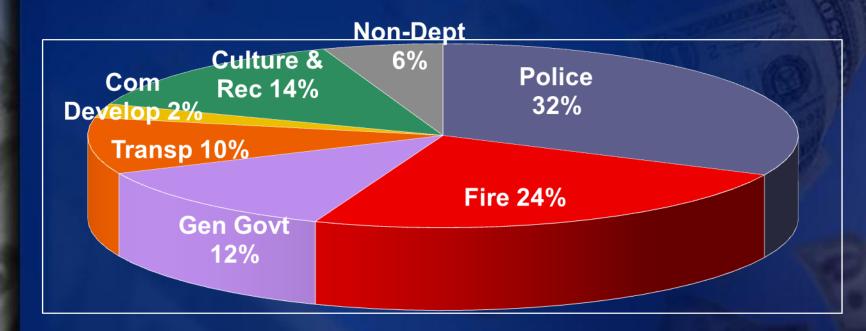
Comment: "The \$1.6m difference between 2014 budgeted and actual expenditures represents a savings of \$648k in salaries and healthcare benefits and \$971k in supplies, contractual services, intergovernmental contracts, travel, motor pool rent, and utilities."
