Summary of significant accomplishments:

On October 10, 2013 the City of Longview approved Ordinance No. 3255 and bylaws for creating the Longview Public Development Authority. Applications for board members were solicited from the community and the City Council appointed Brian Magnuson, Holly McShane, Dave Andrew, George Raiter, and Dean Piotrowski. The Board elected the following officers: Brian Magnuson--President; Dean Piotrowski - Secretary/Treasurer; Bob Gregory was appointed Executive Director.

The Cowlitz County Expo Center Master Plan was reviewed with the intent of moving forward with feasibility studies for both a hotel and a sports complex. A cost sharing partnership for conducting market feasibility studies for a hotel and an indoor sports complex was secured between the City of Longview, City of Kelso, the Public Facilities District (PFD) and Cowlitz County.

RFP's were submitted and reviewed for both studies. Hospitality Marketers International, Inc. (HMI) was selected for the hotel study and final study was completed and submitted to PDA on March 20, 2015. Pinnacle Sports was chosen to complete the sports complex study and draft report was submitted to PDA in February, 2014.

An equestrian center continues to be a topic of discussion and market study will be considered in 2015.

A visit to the Lewis County Event Center & Sports Complex (NW Sports Hub) occurred on Tuesday, October 21, 2014.
