*Mr. Langdon reviewed the staff report. As of July 1, 2016, medical marijuana collective gardens will be illegal. Chapter 19.72 Medical Cannabis needs to be repealed. Staff recommends replacing the repealed chapter with Chapter 19.75.010 Medical Marijuana Cooperative - Prohibited. Due to buffer zones the City has very limited cooperative locations.*

*Chairman Collins opened the public hearing. Hearing no comments, he closed the public hearing.*

**A motion was made by Ms. Ramona Leber, seconded by Mr. Trey Davis, to recommend to the City Council to adopt the subject zoning code amendments to make medical marijuana collective gardens and medical marijuana cooperatives illegal in the City. The motion passed unanimously.**
