Update on Lake Concessions – Big Kahuna Shaved Ice agreement not signed as of this meeting. Lower Columbia School Garden Pizza provided vending for their 1st Summer Concert. They reported 40 pizzas sold that evening and 137 sold at the 2nd concert attended

R.A. Long Park Update – the Parks and Street worked together to remove the concrete plaza. Parks has installed sod and additional irrigation as the first phase of the Master Plan Project. Historic preservation is holding Council to a 2 year plan for future updates to the park.

Jen and Curt presented the Urban Forestry Presentation that is to be used at Rotary. Veterans Memorial Update - Memorial approval by City Council. Attempting to procure funding

Potential Park Land Acquisition – 2 acre parcel on Cowlitz River currently being reviewed as a potential acquisition
