Re: Repair of original squirrel bridge

Adam-

I am working with a group that would like to renovate the original squirrel bridge walkway. The current material is salvaged fire hose which is once again deteriorating. The Parks Department has replaced the hose a few times in the 12 years that I have been involved in the Department. The hoses are obtained from the Fire Department which is hose that they have taken out of service. I would like to suggest that we replace the hose with the rubber belting material that has been used on three most recent bridges that have been installed. The material holds up much better to the weather and has shown no signs of falling apart.

I am requesting the approval of changing the material from hose to belting on the original bridge that is located on Olympia Way just beyond the City Library.

I have attached photos of the current condition of the hoses and also photos of the belting material that is being used on the newer bridges.

I will attend the meeting of the Commission on the 26th to answer any questions that the group may have.

Historical Committee:

Sept. 15, 2016

I have noticed that the Nutty Narrows bridge belt (Firehose) is falling apart. On the North end the end of the hose that should reach the tree is hanging down about 3 feet. Along the south side of the bridge the hose is coming apart. The squirrels that make it to the north side can't get to the trees to get off the bridge.

I have had the fun of putting together all of the current squirrel bridges that the Sandbaggers have put up. I do the finish work of adding the lines and the tread so that the bridges are ready to hang on both of the trees. I also redo and make sure the bridge is safe to put up.

With the approval of your committee I would like to take Nutty Narrows down and repair it so that it can look great again. I have already talked to Curt Nedvid about the removal and he said the City could remove it. I think he is comfortable with me doing the repairs to it. My goal is to do it as quick as possible.

Now comes the question: The current tread for the squirrels is made of firehose and what I would like to do is replace it with a tread like the other bridges have that should never need to be replaced again. I use a tread made by Goodyear and custom cut it to fit and the length of the span. It is bolted to the wires so that it cannot drop off the wires that is hanging from and on. The firehose is usually donated by the fire dept. and is to worn to use for their work. So it is currently used on the bridge and lasts only about 6 to 7 years. Causing the bridge to be removed and be repaired every 6 to 7 years. My fix will mean that doesn't need to come down for a tread failure.
