

**AMENDMENT NO. 1 to
INTERLOCAL AGREEMENT BETWEEN
THE CITY OF LONGVIEW AND COWLITZ COUNTY
FOR DELIVERY OF TECHNOLOGY SERVICES**

1. This Amendment No. 1 to the Interlocal Agreement is between Cowlitz County, Washington, ("COUNTY"), and the City of Longview, ("CITY") and shall take effect and be in force on the below stated date of authorization as agreed to by COUNTY and CITY.
2. COUNTY AND CITY have entered into an Interlocal Agreement for information technology services, as more specifically described in the Agreement between the parties dated July 1, 2014 and attached hereto as Attachment "A".
3. COUNTY is now in need of continuing or modifying the scope of information technology services provided by the CITY to COUNTY as described in the original Agreement dated July 1, 2014. The additional services are set forth below in Section 4. CITY is amendable to this amendment, under the same terms and conditions of the original Agreement.
4. Both COUNTY and CITY agree to modify the original Agreement as in the parties' best interests and in furtherance of the purposes and intent of this amendment, as set forth below:
 - a. CITY will provide services to COUNTY to implement the Spillman Jail Management System (JMS) which will replace COUNTY'S current JAMS system, as more particularly described in the Spillman Project Proposal dated August 18, 2016, updated October 5, 2016, and attached hereto as Attachment "B".
 - b. CITY will provide COUNTY on-going administrative, operational and maintenance support for the JMS, as more particularly described in the original Agreement between the parties dated July 1, 2014 and in the Spillman Project Proposal dated August 18, 2016, updated October 5, 2016, and attached hereto as Attachment "B".
 - c. In the event of an inconsistency in this Amendment and the original Agreement, the inconsistency shall be resolved by giving precedence in the following order:
 - i. Applicable federal and state statutes and regulations
 - ii. Amendment #1
 - iii. Agreement dated July 1, 2014
 - iv. City's Spillman Project Proposal
5. Except as provided above in this Amendment No. 1, all terms, conditions, duties, obligations and provisions of the original Agreement and any prior Amendment(s) shall remain in full force and effect.

The parties hereto have executed this agreement on this February _____ 2017, and each signatory to this Amendment No.1 warrants that it is duly authorized and executes this Amendment for and on behalf of the below-inscribed parties hereto.
