Construct two gravel footpaths with two gravel pads and add a covered shelter inside the Gerhart Gardens Dog Park. The first footpath will connect the gate of the SMALL OFF LEASH AREA to a new gravel pad and covered shelter. The second gravel footpath will extend from the covered shelter in the LARGE OFF LEASH AREA to a new gravel pad. The gravel footpaths and pads should be constructed in the same manner as the footpaths and pads already within the park. Construction of the covered shelter will follow both the manufactures and city requirements. (Please see attached drawings and Google Images)

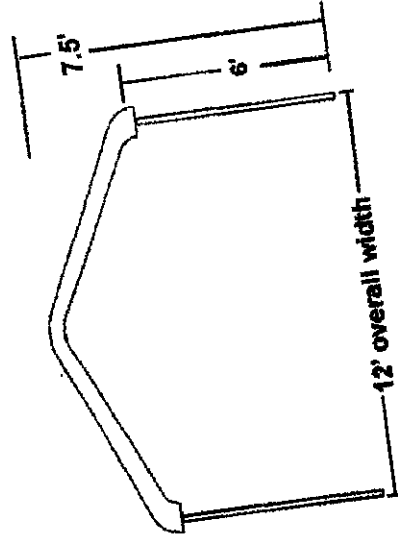
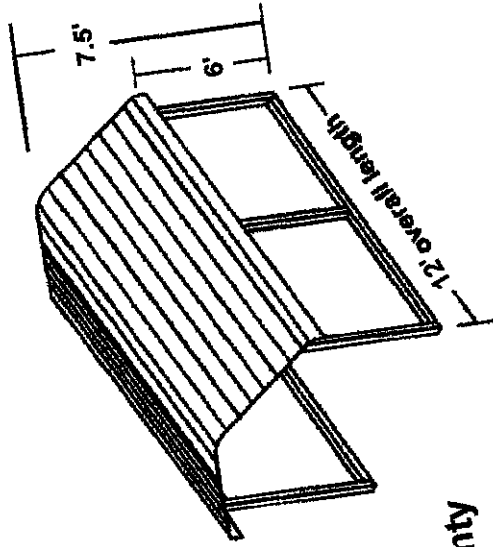
Funding: The potential sources for funding are donations from citizens and in-kind donations in the form of volunteer labor. Currently we have \$ 940.00 cash.
