Steve Haubner, Stormwater Manager, gave a PowerPoint presentation on the Stormwater Low Impact Development Code Review and Update. The City of Longview's Municipal Stormwater Permit through the Department of Ecology requires locals governments to adopt relevant provisions in the local code. Longview is obligated to review and adopt new codes and standards by June 30, 2107. These updated codes and Best Management Practices (BMPs) will not affect current development and are only for new and re-developments. Mr. Haubner is hoping for minimal effects on single family lots and mainly design tweaks for developers. A public hearing will be held mid-May, set as a special meeting.
