Project Description: The Longview Pioneer Lions have been an active contributor to the projects on Lions Island for many years and have kept the holiday traditions in place on a yearly basis. The Pioneer Lions are gradually replacing the outdated holiday decorations on the Lions Island and are requesting assistance this year in adding "Candy Cane" & 3 "Gift Packages" all LED lit.

These will replace aging, broken and energy inefficient decorations. The replacement items were quoted by DeJulio Displays as costing \$2,430.0 including tax & shipping. We anticipate some additional electrical and misc supply needs.

We feel this is a major part of the holiday display and would continue to benefit the community while improving the quality of the holiday decoration and save on energy cost.

What are the needs for the community?

Each year the Longview Pioneer Lions Club provide for the holiday decorations on Lions Island. The community has the need to find uplifting activities during the holiday season and spiritual atmosphere with the holiday decorations on the island provide a positive holiday response. It also brings pride to the community.

Community Impact: The uplifting holiday lighting provides a positive atmosphere where the community can take pride in knowing that the uplifting displays can create a more positive community attitude and atmosphere.

Access: Access to Lions Island is detoured during the holiday season due to the lighting project. With the equipment and materials needed for the displays it is highly recommended that the Island be closed off during the one month period. Safety is a concern.

Financial Responsibility: Ernie Kuntz had a great understanding of replacing material that becomes outdated and worn. He left a considerable amount of resources to counter the aging process. We expect decades of use from these decoration (as we used that sets being replaced).

Cost benefits: The cost benefits to the public include a more uplifting program that is enjoyed, not only for local citizens, but those visiting our community. With the outdated decorations we face a multitude of repair concerns & costs.

Compliance: This project on Lions Island has been in compliance with the Longview Historic Plan and all other City policies. This project has been a very positive attraction in the Longview community for a great number of years.

Readiness to Proceed: The Longview Pioneer Lions begin working on the decoration process after the summer activities in the community and usually start preparing the equipment, lights, and display ideas in September. We do have to order supplies early and therefore would start the process sometime in



July. Once equipment and supplies are on site, the Pioneer Lions Club goes to work testing and packing the displays.

Funding: The Longview Pioneer Lions Club pays for most of the maintenance on Lions Island through their own budget process and at times will receive grants to help upgrade the decorations on Lions Island. This new decorations will be this year's project and will be the latest upgrades for the island display. We are very proud of the partnership with the City of Longview and the Longview Parks Department. Each year the partnership provides for the assistance of a crew with aerial trucks and man power to help with the elevated decorations. This service is also provided at the conclusion of the season.

Additional: The Longview Pioneer Lions Club takes pride in the Lions Island holiday decorations and will start preparing the displays in October with the inspection and repair of the decorations, this involves 15 to 20 members and volunteers, which spend about six hours a day. This project is then transported to the Island where the displays are put into service; this takes a minimum of three full days and includes 10 to 12 members and assistance from the Longview City Crews and high-lift vehicle. The same will happen at the end of the season when the displays must be removed and stored. The Pioneer Lions will also assist with manpower for the Cities displays at the Civic Circle. This project logged approximately 360 man hours in 2016.
