16-4288 PROPOSED SALARY SCHEDULE FOR LONGVIEW CITY COUNCIL

SUMMARY STATEMENT:

As stated in the Longview Municipal Code, the purpose and duties of the Longview Citizens' Commission on Salaries of Elected Officials shall be to meet no less often than once during each even-numbered years, prior to the first day of June of such year, to study the relationship of salaries to the duties of members of the Longview city council and the mayor of the city of Longview, and fix the salaries for each respective position.

At three meetings in early 2016, the salary commission met to evaluate the council salaries for comparably sized cities in the state of Washington and self-reported data from the council members about the amount of time they spend performing their council duties each month. These materials are attached for reference. The current salary schedule (\$1500.00 for mayor; \$800 for mayor pro tem; and \$750 for council members) was adopted by the salary commission in 2008.

On March 29, 2016, the commission voted to recommend the following monthly salary schedule:

Mayor: \$1500.00

Mayor Pro Tem: \$950.00 Council Member: \$900.00

Not less than 30 days prior to the filing of any proposed salary schedule with the city clerk, the commission shall conduct a public hearing thereon. At the conclusion of said public hearing, the commission shall adopt the proposed salary schedule together with any amendments thereto or changes therein as determed by the commission.
