By adjusting some setback standards, the proposal will allow for more efficient use of land. The reduced side yard setback for parking in the rear yard will allow for 5 parking spaces instead of 4 with the standard 50 foot wide lot. The ability to an additional parking space should not have a substantial adverse impact on neighboring properties.

In the R-3 and R-4 Residential Districts, for new development where vehicle access to parking is from the alley, the City already allows for a 10 foot front yard building setback. In existing neighborhoods the frontyard setback is 20 feet. In the past the City was concerned that allowing a lesser setback (10 feet) when all the existing building were setback 20 feet would impact the look and feel of a neighborhood. In the interest of effecient use of land, the City is looking to allow the lesser setback in existing neighborhoods. Although the lesser impact could have some impact on aesthetics and crime prevention through environmenta design, the impacts to the neighborhood are not substantial.

**SUBJECT:** Side yard setbacks for parking in the rear yard & front yard setbacks for multifamily buildings

At the March 14 special meeting, the Planning Commission agreed to initiate a zoning code amendment process to address setbacks for parking and front yards setbacks for buildings in residential districts. Proposed amendments were provided to you at the March meeting. The proposed amendments given below are different from the ones given you in March. Staff believes the following proposed amendments better address the specific issues this round of amendments were meant to address.

As usual, text that is underlined is new wording, text that has a line through it is meant to be deleted.

# Chapter 19.78 Off-Street Parking and Loading 19.78.030 Spaces – Location.

(2) All off-street parking spaces located in the residential districts R-1, R-2, R-3, R-4, and TNR shall be located so as to not encroach in any required yard setback area., except that parking shall be permitted in the rear yard setback area for those properties with alley access
Exception: for those properties where parking is accessed from an

alley, parking shall be permitted in the rear yard and the side yard setback adjacent to that parking may be reduced by 50%.

# Chapter 19.20 Residential Zoning Districts Section 19.20.030 Density and dimensional standards.

3. <u>In the R-1, R-2, and TNR districts</u>, the reduced front yard setback applies to lots in a subdivision or short subdivision where the reduced setback was approved as part of the overall approval process for the subdivision or short subdivision. To utilize the reduced setback, alley access must be provided and all off-street parking, garages and driveways for a given lot and residence shall be located and accessed from the alley.

The proposed amendment for the parking chapter would allow some flexibility in allowing rear yard parking to also encroach into the side yard. The amendment to the residential chapter would allow for development in the R-3 and R-4 districts with parking only off the alley to have a 10-foot front yard setback in existing neighborhoods as well as new developments.
