# <u>19-5764</u> ALCOHOL POLICY - CITY OF LONGVIEW PARKS

COUNCIL STRATEGIC INITIATIVE ADDRESSED: Address Quality of Place

# SUMMARY STATEMENT:

With the direction provided by Council to allow for expansion of special events, the Department and the Parks and Recreation Advisory Board worked together to create guidelines that would provide direction in executing the current park code:

LMC 13.01.190. Park Code (LMC 13.01.190 reads - Possession or consumption of alcoholic beverages in public parks) states that it is unlawful for any person to consume or possess any unsealed or opened container of alcoholic beverage in a public park; *provided, this prohibition shall not apply to organized groups which have secured a permit from the director* and, if required, from the Washington State Liquor Control Board.

The consumption of alcoholic beverages continues to be prohibited at all City of Longview parks and other outdoor public places, unless a Special Event Permit has been awarded, permission for serving and consuming of alcohol has been granted, the event takes place within the approved site, and the subsequent conditions and requirements laid out within the guidelines are followed.

At the August 9, 2018 Council provided direction on the previous draft policy presented to include restricting alcohol service only at R.A. Long Park, providing for an opportunity for private events to serve alcohol, and the requirement of all those who serve alcohol at special events to be (MAST) Mandatory Alcohol Servers Training permitted. These changes were brought to the Parks and Recreation Advisory Board for recommendation.

# 19-5756 CONSULTANT AGREEMENT WITH GIBBS & OLSON FOR WEST LONGVIEW SEWER LAGOONS REDEVELOPMENT FEASIBILITY STUDY

# COUNCIL INITIATIVE ADDRESSED:

Provide sustainable water quality and environmental infrastructure Strengthen economic conditions & create new opportunities

#### CITY ATTORNEY REVIEW: NOT REQUIRED

#### SUMMARY STATEMENT:

The West Longview Lagoons Sewer Treatment Plant was taken out of service in March 2012, and accumulated biosolids removed in 2014. The City Council has expressed interest in determining the feasibility of developing single family and/or multifamily residential housing on the property. To determine the technical feasibility of development, the proposed scope of work provides for a boundary survey of the City property due to uncertain boundaries as depicted by the Cowlitz County Assessor; identifying how water, sewer, power, natural gas, and other utilities might serve the development; roadway capacity and access to the site; and geotechnical review of on-site soils to determine groundwater levels, the amount of fill needed, and estimate settlement due to the fill necessary to use the site.

Rather than focus only on residential development, the proposed economic analysis includes examining residential and non-residential capacity, utilization, and demands in the potential market area, and will examine options for how to manage the City's development and/or disposition of the property. Options include sale of the property as-is, sale following infrastructure removal and site fill and stabilization, sale with the site stabilized and preliminary development begun with a plat or similar planning commitment and construction of interior roads, utilities, and access to adjoining public roads, or other potential options.

In accordance with state law, staff selected the Gibbs & Olson consultant team as the most qualified firm based on responses to a Request for Proposals. The Gibbs & Olson team includes Ecological Land Services for environmental analysis, Shannon and Wilson for geotechnical analysis, and Johnson Economics for the market and economic analysis. The proposed Scope of Work is attached.

#### FINANCIAL SUMMARY:

The Gibbs & Olson contract amount for the feasibility study is \$214,000. This work will be paid by the Sewer Utility fund.

#### <u>19-5757</u> 7TH AVENUE REQUEST TO LOWER POSTED SPEED AND INSTALL PEDESTRIAN WARNING BEACONS

#### COUNCIL INITIATIVE ADDRESSED:

Improve transportation systems

#### CITY ATTORNEY REVIEW: N/A

#### SUMMARY STATEMENT:

Staff has received safety complaints regarding 7th Avenue between Tennant Way and Hudson Street. The two main complaints are speeding and the assertion that the posted speed is too high for the conditions, and that vehicles do not stop for pedestrians waiting to cross 7th Avenue. A pedestrian warning beacon such as the rapid rectangular flashing beacon (RRFB) was requested to improve safety for pedestrians crossing 7th Avenue.

Staff has evaluated the requests and summarized our findings in a staff report that evaluated crash history, vehicle speeds, and traffic volume. Staff has determine that the crash history warrants taking action on 7th Avenue. There are two locations in the City that have higher crash rates than this stretch of 7th Avenue: Ocean Beach Highway between Cowlitz Way and 15th Avenue, and the Civic Circle. To address the crash rates, staff has identified countermeasures to improve site distance for side street traffic and pedestrians, and increase channelization and visual clues for drivers.

Staff recommends trying countermeasures and evaluating if the countermeasures address the crash rates and improve crossing opportunities for pedestrian. Staff does not recommend lowering the speed limit as the first course of action until countermeasures have been put into place and evaluated. Most drivers maintain a speed that is reasonable and prudent. If the speed is lowered, almost 50 percent of the drivers currently using 7th Avenue may violate the speed limit because most drivers maintain their speed based on the driving environment, more so than by the posted speed limit. Staff recommends installing a RRFB beacon at the Delaware Street pedestrian crossing.

#### FINANCIAL SUMMARY:

Constructing curb extensions and a pedestrian warning beacon will cost approximately \$190,000. Pavement markings for channelization could be temporarily applied in paint to determine their effectiveness, utilizing the existing Traffic Division budget. Longer lasting thermoplastic pavement markings are estimated to cost \$85,000 and would require hiring a contractor.

#### **RECOMMENDED ACTION:**

Motion directing staff to construct pedestrian warning beacons and curb extensions on 7th Avenue at Delaware Street, and paint a double yellow centerline and edge line.
