**CITY ATTORNEY REVIEW: N/A****SUMMARY STATEMENT**

This public hearing is to allocate 2015 HOME Investment Partnership Program funding, and Document Recording Fee project funding. The Public Hearing will be held to review and consider affordable housing projects submitted for funding and receive public comment for allocations.

Three (3) HOME projects and two (2) Document Recording Fee projects have been received. All project designs have been made available for Council review. Public Review has been made available at the Community Development Office and on the City's HOME Website.

Funding for 2015 HOME's Longview-Kelso Consortium is at \$223,093 of which Longview's portion is \$117,123.83.

2015 Document Recording Fee funding from Cowlitz County totaling \$24,447.49 and will be available for low-moderate housing, below 50% income, and shelters.

*Prior to the public hearing, Director of Community Development John Brickey introduced the 2015 HOME funding and Auditor's Document Recording Fees funding process. Longview and Kelso have created a Consortium for receiving and allocating funds. The amount available to the Consortium this year is \$223,093, which is less than last year's allocation.*

*Seventy percent of the funding is available for projects; Longview's share is 75% of the amount, which is \$113,123.83 for 2015.*

*Mr. Brickey outlined the three projects that had been submitted for possible funding: CAP's proposed affordable rental housing for three families; LifeWorks/Foundation for the Challenged proposal for one group home; and Community House on Broadway's proposal for tenant-based rental assistance.*

*Eligible for Document Recording Fees funding were two proposals: Operations funding for Community House on Broadway in the requested amount of \$23,500, and operations funding for Emergency Support Shelter in the amount of \$9,000. There is approximately \$24,000 available to be allocated.*

*Mayor Jensen opened the public hearing at 7:26 p.m.*

*Michael Torres, with CAP, advised Council the period of eligibility is 15 years. The property CAP is looking at is currently a blighted property. They plan to construct a triplex, thus providing new housing stock, dense housing, up-to-code and affordable housing. They have CHDO funds that must be spent this year.*

*Marty Johnson with Life Works said their project would provide low-income housing for those with learning disabilities; they also need access to low-income housing. The \$45,000 LifeWorks has requested would be a local match to show other grantors the local municipality supports the project.*

*Director of Community Development John Brickey said reducing the funding to CAP might hamper their project. Mr. Brickey said HUD requirements for funding use is trending toward HUD funds being the final amount needed to conclude a project. Since CAP has lined up other funding, their project would meet HUD's model.*

*Community House on Broadway Executive Director Frank Morrison spoke about his organization's funding request and the importance of providing mental health care. Many homeless people have mental illnesses. He referred to the co-pilot that flew a jetliner into a mountain; typically, these people are loners. He said CAP receives quite a bit of money from Cowlitz County.*

*Regarding the Auditor's Document Recording Fees funds, Mr. Morrison suggested funding the Emergency Support Shelter's entire \$9,000 request. But he also asked that his program be allowed to succeed.*

*Sherrie Tinoco said the requested \$9,000 is for operational expenses. The Emergency Support Shelter assists about 500 people a year.*

*There being no further comment, either oral or in writing, the public hearing was closed at 7:38 p.m.*

*Councilmember Wallin moved to award \$9,000 of the Document Recording Fees to the Emergency Support Shelter, and the remaining balance to Community House on Broadway. Councilmember Makinster seconded this motion. Upon a vote duly held, the motion was unanimously approved.*

*Councilmember Melink moved to award the entire HOME funds available to the CAP low-income housing project; this motion was seconded by Councilmember Moon.*

*Councilmember Wallin moved to amend the previous motion by allocating \$45,000 in HOME funds to LifeWorks; \$39,000 to Community House on Broadway; and the balance to CAP for its low-income housing project. This motion was seconded by Councilmember Makinster.*

*Councilmembers Melink and Hutchinson expressed their opinion that the CAP project might not get off the ground if their funding is cut. CAP may even lose previously awarded funding.*

*Councilmember Wallin advised he made the motion to amend in order to help a greater number of people.*

*Upon a vote duly held, the motion to amend failed with only two "aye" votes cast by Councilmembers Wallin and Makinster.*

**A motion was made by Mayor Pro Tem Mary Jane Melink, seconded by Council Member Steve Moon, that all available HOME funds be awarded to CAP. The motion passed with no nay votes.**

**ZONING TEXT AMENDMENTS REGARDING PUBLIC PARKS AND RV PARKS IN THE HEAVY INDUSTRIAL DISTRICT**

**COUNCIL STRATEGIC INITIATIVE ADDRESSED:**

Council Initiative: Preserve and enhance neighborhoods; Address quality of place issues

**CITY ATTORNEY REVIEW: N/A**

**SUMMARY STATEMENT:**

Public parks are not a permitted use in the HI district. Gerhart Gardens Park is located in the HI district and is a legal nonconforming use due to its pre-existence prior to the adoption of current industrial zoning regulations. Most passive recreational uses are still allowed under the nonconforming status. However some more intensive recreational uses are not permitted, such as public facilities for athletic events or recreational vehicle (RV) parks. The public park is located near the Tennant Way (SR 432) crossing of the Cowlitz River.

Gerhart Gardens Park provides one of the few opportunities within our community for public recreational access to the waters of the Cowlitz River. A recent inquiry about the possibility of siting an RV park that would provide additional recreational opportunities at the park resulted in staff determining that the HI district does not allow for that use. Removing the nonconforming status of the Gerhart Gardens Park along with additional zoning code amendments would not only allow for the proposed RV park, but would also allow for other potential public use recreational facilities to be located at the park.

At their February 12, 2015 regular meeting, the City Council unanimously passed the following motion: Direct staff to present the issue to the Planning Commission for their review and recommendation for Council consideration.

At their March 4 regular meeting, the Planning Commission discussed the issue and reviewed City staff recommended changes to the zoning code. The Commission decided to hold a public hearing on the proposed amendments at their April 1, 2015 meeting. The Planning Commission held a public on April 1. No one from the public spoke. The Planning Commission then unanimously passed a motion to recommend approval of the proposed amendments.

One amendment would make public parks a permitted use in the Heavy Industrial District but an accompanying footnote states that only parks in existence as of January 1, 2015 are permitted. Gerhart Gardens Park is the only public park in the HI District. The result of this amendment is that Gerhart Gardens would become a conforming use in the HI District but no other public parks could be sited in that district. The second amendment along with its footnote would allow an RV park to locate in the Heavy Industrial District but only in association with a public park. Thus, an RV park would be allowed in Gerhart Gardens Park but no where else in the HI district. The specific amendments are given in the attached staff report.

**RECOMMENDED ACTION:**

Move to accept the Planning Commission recommendation and direct the City Attorney to prepare an ordinance for Council review and approval.

*Mayor Jensen commented that Downtown Streetscape "looks good." He also had a great weekend at Mint Valley Golf Course participating in the new Disc Golf Course.*

*Interim Director of Parks & Recreation Jenn Wills said they had a very successful ribbon-cutting and first day at the Disc Golf Course; more people showed up than had been expected to participate in the opening-day tournament. She felt this was a good amenity for the park.*

**ADDRESSING QUALIFICATIONS OF TAXICAB OR FOR-HIRE  
VEHICLE OPERATORS**

**INTRODUCED BY: Councilmember Mike Wallin**

**SUPPORTED BY: Councilmember Steve Moon**

**COUNCIL STRATEGIC INITIATIVE ADDRESSED:**

Strengthen economic conditions and create new opportunities.  
Improve transportation systems.

**CITY ATTORNEY REVIEW: REQUIRED**

**SUMMARY STATEMENT:**

Ecocab, LLC owner/operator Mr. Ron Knori has expressed concern about finding qualified local operators/drivers for his local taxicab company. Mr.

Knori's local operations have expanded outside the immediate area and into Portland, OR. He is asking that Council make a change to LMC 5.80.080 to allow qualifying individuals with an out-of-state drivers license be eligible to apply for a Taxi/For-Hire Operator's License.

**RECOMMENDED ACTION:**

A motion directing the City Attorney to prepare an ordinance for adoption by Council amending Longview Municipal Code (LMC) 5.80.080 Section (6) by striking "(6) Possess a valid State of Washington driver's license; and" and replacing it with, "(6) Possess a valid driver's license; and" and to place the ordinance on the May 14th, 2015 agenda.

*Councilmember Wallin moved to amend the Taxi Driver code to allow out-of-state drivers to work in Longview, and to direct the City Attorney to draft an Ordinance effecting this change, and to bring it back to the May 14, 2015 council meeting. This motion was seconded by Councilmember Moon.*

*Ron Knori of Eco Cab had petitioned Council for this and other changes to the Taxi Driver regulations. He did not know why cab drivers were restricted to Washington-only driver's licenses. He is planning to expand his business into other areas, and he would like to be able to move drivers around as needed.*

*Chief Jim Duscha acknowledged that his department would continue to perform background checks on all prospective drivers, whether they had a Washington license or license from another state.*

*Since there is a 9% unemployment rate in Longview, Councilmember Botero could not understand how there is a shortage of drivers. "Why open this up to insiders?" Why change something that benefits our community? Mr. Botero asked whether all the other local taxi companies were in favor of this change.*

*Councilmember Moon stated he believes the language is a little dated. He also believed that if Council is going to make changes to this LMC section, the entire section should be reviewed for changes/modifications.*

*Local taxi company owner Mike Fittro said he agrees with Councilmember Botero. He said he is continually being asked about driver positions. "It only makes sense to have local people drive" since they are familiar with the city and outlying areas. There are plenty of people who want these jobs.*

*Councilmember Moon questioned whether Rainier is considered local.*

*Mr. Fittro said he is a Cowlitz County employer.*

*Ron Knori, Eco-Cab owner, said he had been approached by John Oliver from Clatskanie for a driving position. Mr. Knori said "I don't have a huge agenda;" he is just trying to open up jobs for people who are qualified and want to work. He said he has more cars than drivers available during peak times.*

*Council expressed concern that a change to the code was being proposed to benefit one individual. That being said, several councilmembers reported they did not have any objection to this change.*

*Councilmember Botero voiced his opinion that perhaps the entire LMC section should*



*be reviewed. He cannot support this amendment, but he is willing to work with Council to review the entire code. Councilmember Wallin offered to free up his Tuesday nights to go through the code line by line.*

**SUMMARY STATEMENT:**

The project includes construction of streetscape improvements including sidewalk and ADA ramps, bio-filtration planters and stormwater facilities, paving, and trees and landscaping improvements. The improvements will be made on Tennant Way from 7th Avenue to 15th Avenue.

*Councilmember Botero asked whether the concerns expressed by Tennant Way businesses had been addressed prior to finalization of the plans. COLLECTIVE BARGAINING AGREEMENT, JAN 1, 2015 - DEC 31,  
2017**

**CITY ATTORNEY REVIEW: REQUIRED**

**SUMMARY STATEMENT:**

On March 26, 2015, Longview Employees' Bargaining Association (EBA) and the City reached a tentative agreement on the 2015-2017 Collective Bargaining Agreement (CBA). Multiple articles in the contract were opened for review and some language changes to clarify/improve the contract were made. EBA notified the City of member (97) ratification on April 21, 2015. The contract provides for a \$0.62/hours COLA, beginning December 31, 2015, and a COLA increase of 100% of Portland CPI-W in 2016.

For 2015/16 the CBA remains at 100% employer paid HDHP medical insurance plan and Dental remains at 80% employer paid.

For 2017, both parties agree to open for bargaining Article 11, Medical and

Insurance Benefits and Article 21, Salaries for the purpose of negotiating salaries and calculating the balance of 2015 deferred wages that may be applied to the 2017 medical premium.

Employees opting out of City medical insurance coverage will receive a VEBA contribution of \$825/ month in 2015 and 2016.
