### 15-4110 2016 FEDERAL LEGISLATIVE AGENDA

#### SUMMARY STATEMENT:

Presentation by Joel Rubin of the proposed 2016 Federal Legislative Agenda for the December 3rd workshop.

#### Attachments: 2016 LONGVIEW FEDERAL AGENDA

*City Manager Campbell introduced Joel Rubin, federal lobbyist for the City of Longview, to present the proposed 2016 Federal Legislative Agenda.* 

*Mr.* Rubin presented a slideshow highlighting the policy successes between 2007 and 2014, including \$1 million for the water treatment facility; \$450,000 for COPS Meth Project; \$663,984 for COPS hiring (three officers over three years); \$1.4 million EDA Grant for Weber Avenue/Mint Farm; \$17.8 million in clean water and drinking water stimulus loans; \$575,834 for firefighters (four positions over four years); stormwater fee legislation (\$4,800 per year); \$1.12 million biodiesel bus acquisition; \$800,000 for regional 911 computer aided dispatch; and \$373,500 for biodiesel bus acquisition.

*Mr.* Rubin also provided an update of 2015 policy provisions, including the protection of CDBG/HOME for small entitlement cities; an increase in police equipment funding; the maintenance of funding for assistance to firefighters; Lake Sacajawea permitting/flushing; internet sales tax bill; the elimination of sequestration for two years (FY16 and FY17); and funding for CDBG, HOME and TIGER. Mr. Rubin also provided a recap of 2015 and a timeline for 2016.

Council discussed the major transportation related policy successes of 2015, such as the SR432/SR433 Highway and Rail Corridor Capacity and Safety Improvements (Oregon Way and Industrial Way intersection).

Council agreed to add language to the federal agenda to address crude oil by rail concerns, as there is a proposal for a mini oil refinery to be located at the Port of Longview. Fire Chief Jurmu emphasized that a focus on prevention rather than containmnent is key to protecting the community; once a disaster has occurred, there is little that can be done by firefighters other than to contain the fire.
