6. Consideration of Invoices

On a motion from Weber, seconded by Roberson, the invoices were approved for payment. The motion carried unanimously.

7. Manager's Report

Asher reported sales tax for November was 6.7% over November 2015. Year to date we are 10.7% over the previous year.

Ridership is maintaining a consistent 7% decline compared to 2015. Staff will be focusing on marketing strategies and a community outreach program for 2017 including trying to engage more of the local schools.

Regional transit agencies from our five-county Regional Transportation
Planning Organization met to review and rank projects submitted for
consideration for a WSDOT Consolidated Transit Grant. Staff submitted a grant
for paratransit operating funds and another for replacement of three
paratransit vehicles. The region's ranking will count for one-third of the total
possible value of the state's competitive process.

A = 50 percentage points

B = 25 percentage points

C = 12 percentage points

D = 0 percentage points

The operating grant received an A ranking and the capital project received a B ranking.

The suggested grant ranking list will go to the RTPO Board meeting for consideration in January.

Jensen asked if staff has reached out to the casino about our vanpool program. Nolen responded that he approached them at the Woodland Job Fair and that there did seem to be an interest.

Currently, Nolen is working with American Workforce group who is starting a vanpool that will go to a Toledo Tree farm. We have the applications and an approved driver.
