## 8. Open Public Meetings Act Training

The Longview City Council is taking Open Public Meetings Act Training during the Council meeting to be held April 13, 2017. Alexander, the City of Kelso delegate said they had the training during the previous year.

### 9. Marketing and Mobility Management

Asher reported she would be attending Earth Day to promote RiverCities Transit. RiverCities will also have a booth at the Senior Connections Fair.

Lamar Advertising has produced channel cards and floor coverings for the buses. The images depict Google Trip Planning, bus safety, and exit arrows.

Cowlitz County Health and Human Services is launching Walk and Roll Month. RiverCities will be offering Fare Free Fridays during the month of May as part of the Walk and Roll program.

Staff has organized events, added channel cards on buses, started a Facebook page as part of the Mobility Management Grant. Staff will be wrapping up this grant with an updated RiverCities LIFT application. The new application will be cleaner, have a clearer message, and be shorter. Staff will also be producing a new LIFT rider's guide.

## 10. Manager's Report

Asher reported sales tax is up 4.1% over the previous year and up 7.6% for February. Melink asked that staff provide a graphic in the next agenda packet. Weber stated he is interested in the effect of the 1/10% sales tax increase on transit.

Asher stated ridership has declined. Staff is reviewing routes that are less productive. Staff will review 2015 performance measures.

The ATU has ratified their collective bargaining agreement; staff is working on the implementation of that contract.

Kelso School District asked to postpone their discussion of our operator recruitment practices. Weber asked if the hiring issues were generational, is there a way to recruit and attract a younger generation. Asher responded that staff will be attending the LCC career fair. Staff is looking into a way to add a training piece as the City currently requires a CDL with passenger endorsement. Staff is also looking at how to make the Casual/on-call a more appealing position.

Washington Department of Transportation site review was held. The review included financial, staff policies and procurement. There were no findings.

The FTA will hold their triennial review during the beginning of May. This review includes on-site interview and tour of facilities.

TCF Architecture is in the design phase of the transit center expansion. Staff is expecting to go to bid in early November.
