The salary commission reviewed the 2017 AWC Salary Survey and discussed the roles & responsibilities of the mayor, mayor pro-tem & council members.

It was agreed that the mayor's salary is already in-line with the salaries of mayors in similarly sized Washington cities with the council-manager form of government.

A motion was made by Robert Patterson, seconded by George Brajcich, to direct staff to prepare a resolution to increase the salaries of the mayor pro-tem and council members by \$25 a month this year and \$25 a month the following year (a \$25 monthly increase for twelve months effective upon the official filing date of the new salary schedule and a second \$25 monthly increase after the first twelve month period). A public hearing will be held before the salary commission can consider adoption of the proposed increases. The motion passed by the following vote:

Nays - Jeff Wilson**

A motion was made by Robert Patterson, seconded by Nicholas Higgins, to leave the mayor's salary as-is. The motion passed unanimously.

5. **PROVIDE STAFF DIRECTION & SCHEDULE NEXT MEETING**

The salary commission directed City Clerk Kaylee Cody to schedule a meeting for March 19, 2018, at 5:00 p.m. to hold a public hearing and consider a resolution to increase the mayor pro-tem & council members' salaries as previously proposed and voted upon.

In response to an email to the salary commission from Jone Fluruth urging the commission to evaluate salaries based on Gross Domestic Product (GDP), the salary commission directed City Clerk Kaylee Cody to research the GDP for Longview and each comparable city and provide the results by mail prior to the next meeting of the salary commission.
