PUBLIC HEARING - REQUEST TO VACATE THREE SECTIONS OF EXCESS UNIMPROVED RIGHT OF WAY ABUTTING PROPERTY OWNED BY COWLITZ COUNTY

COUNCIL STRATEGIC INITIATIVE ADDRESSED:

Preserve and enhance neighborhoods Continue effective financial management

CITY ATTORNEY REVIEW: N/A

SUMMARY STATEMENT:

Cowlitz County, which represents 100% of the abutting property, has submitted a request to vacate three separate sections of unimproved right-of-way lying adjacent to Cowlitz County property located near 7th Avenue. This request has been reviewed by appropriate City staff and utility

companies and approval would include retaining public utility easements in the proposed vacation areas.

In accordance with state law, Resolution No. 1732 provides for charges to the abutting property owners of up to 100% of the appraised value of the vacated area if the right-of-way has been dedicated for 25 years or more. All three sections of right of way were dedicated over 25 years ago, thereby allowing the City to charge 100% of the appraised value of the vacated area.

In lieu of payment, Cowlitz County has proposed a property trade with the City for the vacated areas. A new parcel containing approximately 1.8 Acres within the Cowlitz County Event Center boundaries will be transferred to the City of Longview, along with utility easements for future development of the new parcel. The County will retain utility easements for existing utilities crossing the new parcel, and provide access to the parcel by dedicating a public street right-of-way for extension of 5th Avenue from Washington Street.

RECOMMENDED ACTION:

Motion to:

- 1. Approve the proposed vacation contingent upon transfer to the City of the proposed new parcel and associated easements by Cowlitz County.
- 2. Direct the City Attorney to prepare the right of way vacation ordinance for adoption after the transfer of property from Cowlitz County.

18-5457 HARLIE'S HOOPS PROJECT APPROVAL

SUMMARY STATEMENT:

Harlie's Angels is a non-profit organizations based on equipping and empowering teens to grow into God-loving, responsible, caring, young adults through sports, service, and fellowship. (www.harliesangels.com) Jennifer DesArmo of Harlie's Angels and her dedicated volunteers have been working hard to improve the lives of the community and specifically the lives of the teens at the Longview Center.

Jennifer addressed the Parks and Recreation Advisory Board in October of 2017 and the Historic Preservation Board in November of 2017 to talk about the possibility of a project of this nature coming to Lake Sacajawea.

At a Council Workshop on February 22, 2018, the Parks and Recreation Department presented the Harlie's Hoops Project, a covered basketball court next to the Elk's Memorial Building at Lake Sacajawea Park, for Council to approve of the project concept.

At the workshop, Council unanimously voted to support the concept and to move forward on the first steps of the project. Harlie's Angels worked with Ecological Land Services to undergo a Critical Areas Determination and Impact Analysis for the proposed Harlie's Hoops Basketball Court. This was done in accordance with Appendix A, Shorelines Critical Areas Regulations of the City of Longview Shoreline Management Program, 2015.

Ecological Land Services found that the project would have no impacts to crucial areas as a result of the project. Harlie's Angles would now like to apply for a Washington State Joint Aquatic Resources Permit Application with the City of Longview as the owner of the property. If approved, Harlie's Angles will then move onto the next steps of the process including the public outreach, shoreline permit, height variance request, building/electrical permits, Certificate of Appropriateness, and approval of engineered drawings.

RECOMMENDED ACTION:

Motion to approve the City Manager to sign the Join Aquatic Resources Permit Application allowing Harlie's Angles to move onto the next phase of the project.
