4. Consideration of Minutes for the May 9, 2018 Meeting

8. Manager's Report

Asher reported that staff plans to bring a letter of intent for State DOT Regional Mobility Grant to the next meeting. The focus of this grant is a pilot project bringing RiverCities into the Lexington area.

Asher was a co-host and presented at two Accessible Transportation Community Input meetings. Several agencies and service providers attended and were asked to identify gaps in service or barriers to transportation that their clients struggle with.

Longview Parks and Recreation has approached RiverCities to encourage riding the bus to and from the Crafted Beer and Food Festival on July 21st. RCT is considering sponsoring to advertise to a different audience and see if that may introduce public transportation to a different demographic.

The Longview Downtown Transit Center should be put out for bid during the beginning of July. Staff has signed a lease on the temporary transit center location. Currently, staff is working on securing the building permits.
