	SUMMARY STATEMENT: Astound Broadband, Inc., a Washington limited liability company, has requested a franchise to grant it the right to enter, occupy, and use the City's public rights of way to construct, install, operate, maintain, and repair a fiber optic based telecommunications system. After discussions with Astound Broadband, Inc., and review by the city attorney, staff recommends granting Astound Broadband, Inc., a ten-year franchise agreement, with the option for one five-year extension of the term of the franchise. Ordinance No. 3294 is the proposed franchise agreement. FINANCIAL SUMMARY: The proposed franchise agreement provides for Astound Broadband, Inc., to pay a one-time administrative fee of \$2,000 to defray the City's legal and administrative costs and expenses associated with negotiating and approving the franchise. #### SUMMARY STATEMENT:

Astound Broadband, Inc., a Washington limited liability company, has requested a franchise to grant it the right to enter, occupy, and use the City's public rights of way to construct, install, operate, maintain, and repair a

fiber optic based telecommunications system. After discussions with Astound Broadband, Inc., and review by the city attorney, staff recommends granting Astound Broadband, Inc., a ten-year franchise agreement, with the option for one five-year extension of the term of the franchise. Ordinance No. 3294 is the proposed franchise agreement.

#### FINANCIAL SUMMARY:

The proposed franchise agreement provides for Astound Broadband, Inc., to pay a one-time administrative fee of \$2,000 to defray the City's legal and administrative costs and expenses associated with negotiating and approving the franchise.
